Financial Update ~ Chief Financial Officer Wayne Fanshier reviewed the finance brochure for November and discussed the trends of sales tax collections through August and Agency Expenditures through September. Upon inquiry, Mr. Fanshier explained how the Agency forecasts its sales tax collections.

<u>PUBLIC HEARING</u> ~ Proposed 2015 Budget

Chief Financial Officer Wayne Fanshier gave a brief presentation on the proposed 2015 Budget. (Commissioner Walker temporarily left the room at 4:11 PM and returned at 4:12 PM.). He also announced that Budget Assistant Manager Cathie Reed is retiring and that she has been with the Agency 15 years. He commended her for her help in preparing budgets. He thanked Ms. Reid for her service and expressed his appreciation for her years of service.

The Public Hearing was opened at 4:38 PM.

No comments were provided.

The Public Hearing was closed at 4:40 PM

ACTION AGENDA

1. FS 14-075, Authority to Operate Route 503 Fife to Puyallup Station, Service Effective February 15, 2015 and Continue to Operate Route 504 Edgewood Milton Community Connector Until New Demonstration On-Demand Zone Service Begins in Milton and Edgewood

Tina Lee presented on the Route 503. She recapped the comments that were received by citizens at the October 13th public hearing relating to routes that do not meet performance standards. She noted that the CIT recommends that service continue on this demonstration for one more year, with periodic performance reviews provided to the Board.

She reported on the performance standards of Route 504, noting that it too is not meeting ridership performance standards. She presented the idea of providing an on-demand zone service and gave an overview of how this service would work. She noted that anticipated costs could be between \$50 -\$75.

She noted that staff did not have any demographic information; however, Pierce Transit staff has indicated that it is mixed demographics.

Commissioner Anderson inquired whether zonal service could happen before June given the routes' performance.

Ms. Lee reviewed the processes that are involved and staff will look at the timeline again to see if it can be shortened.

Commissioner Strickland noted concerns about the cost per service hour for the demonstration project and its inefficiency.

Commissioner Eidinger noted he would like to see the on-demand zone accelerated.

Upon inquiry, it was noted that some high demand routes are being passed over. McCarthy noted that the Agency should be allocating resources to service hours and not to FTE positions.

Ms. Lee responded to questions pertaining to cost and the difference between SHUTTLE and what is being proposed in the on-demand service.

A lengthy discussion ensued about the cost per service hour for the demonstration projects and the amount of resources the Agency is expending in areas where public transportation is not utilized after many attempts to attract service.

A discussion ensued about whether it would be cost efficient to run SHUTTLE and the On-Demand Service.

Cost in ridership analysis of the Route 503 and 504 compared to high ridership routes.

Commissioners Eidinger and Strickland <u>moved</u> and seconded to approve Resolution No. 14-059, authorizing Pierce Transit staff to operationalize Route 503, Fife to Puyallup Station, service effective February 15, 2015, with modifications that the service route be amended to include the apartments (located on 20th Street) in the route.

Upon roll call vote, the motion <u>failed.</u> 3-4. (Anderson, McCarthy, Strickland and Walker dissented.)

Commissioner Anderson <u>moved</u> to discontinue the Route 504 Community Connector as soon as reasonably practical.

The motion died for lack of a second.

Commissioners Strickland and McCarthy **moved** and seconded to approve Resolution No. 14-060, authorizing Pierce Transit staff to operationalize Route 504, Milton Edgewood Community Connector until June 2015 or until a new demonstration on-demand zone service, as presented in Exhibit B, begins operating in Fife, Milton and Edgewood.

The motion **failed**, 3-4.

2. FS 14-076, Authorizing Revision of the Non-Represented Employee Salary Structure and One Additional Personal Holiday for Non-Represented Employees

Commissioners Anderson and Strickland **moved** and seconded to approve Resolution No. 14-061, authorizing revisions to non-represented employee salary structure as reflected in Exhibit A and approve revisions to the Pierce Transit Code Section 6.1.1 by granting non-represented employees one additional Personal Holiday as reflected in Exhibit B.

Chief Administration Officer Alberto Lara presented on the item. He also noted that the medical premiums of the non-represented employees will be adjusted to match the costs of represented employees.

Motion carried, 7-0.

INFORMATIONAL BOARD ITEM

Chair Report ~ Commissioners Vermillion and Henderson participated in the evaluation and interview process for applicants of the Community Transportation Advisory Group (CTAG). There are currently four vacancies on the CTAG, and group interviews are scheduled for November 20, 2014 and may continue into January 2015.

The CEO Transition Committee held its first meeting on November 3, 2014 with the Karras Consulting Group. The Committee discussed core competencies, timeline of the recruitment, public stakeholders. Karras Consulting is working on the advertising plan, job announcement and connecting with public stakeholders.

Vice Chair Vermillion noted that he participated in the November 3rd meeting and thought it was a very comprehensive recruitment plan.

Sound Transit Update ~ Commissioner Strickland noted that Sound Transit is working on its longrange plan, route alignment and ballot measure that will be proposed in 2016 to extend its taxing authority.

STAFF UPDATES/DISCUSSION

Real Property Update ~ Senior Planner Janine Robinson provided an overview of Pierce Transit properties that are currently for sale and potential development sites. A short discussion ensued regarding potential developing opportunities in the Dome District.

It was announced that formal Board action will occur in open session following Executive Session. At 6:26 PM the meeting was extended approximately five additional minutes. The announcement of the extension was made to attendees.

At 6:31 PM, the Regular Meeting was convened. Commissioners Anderson and Strickland <u>moved</u> and seconded to authorize General Counsel to attempt to resolve the Pierce Transit vs. Wells Fargo condemnation matter in the range as discussed in Executive Session.

PRESENTATIONS

Operator of the Month for October, Michael Parker ~ Transit Operator Assistant Manager Hazel Whitish recognized Mr. Parker for the great service he provides to Pierce Transit and noted he was selected as Operator of the Month for October. She noted he took a 10-year break from Pierce Transit for an aviation assignment with the Air Force and Pierce Transit is pleased that he has returned.

Recognition for 40 Years of Service, Danny Wydra, Transit Operator ~ Transit Assistant Manager Hazel Whitish honored Mr. Wydra for his 40 years of service. She noted he has an accident-free record and he always provides great customer service.

Mr. Wydra recapped the changes he has seen while at Pierce Transit and noted he has enjoyed his tenure at Pierce Transit. Mr. Wydra was provided with a gift on behalf of fellow transit operators and other staff members.

Driven by Art Program ~ Chief Operations Officer Doug Middleton introduced Transit Operator Bobbie Hausenbuiler, the developer/founder of the Driven by Art Program.

Mr. Hausenbuiler explained what the program is about and how it will be of benefit to employees. [A small art exposition was displayed at the back of the room for preview.]

Commissioner Vermillion suggested that they contact the Washington State Fair to showcase the art.

Commissioner Walker noted her appreciation that Pierce Transit started the program.

1. FS 14-084, Adoption of the Annual Budget for Fiscal Year 2015

Commissioners Anderson and Keel <u>moved</u> and seconded to adopt Resolution No. 14-067, adopting the 2015 Budget as presented. [Clarification: with the caveat that the Budget would be amended in March of 2015 to include the addition of 12,000 additional service hours.]

Chief Financial Officer Wayne Fanshier presented on the item. He reviewed a PowerPoint presentation that showed a plan to add 12,000 additional service hours in addition to the 4,000 hours that were already proposed in the 2015 Budget.

Principal Planner Peter Stackpole discussed capacity issues and resolutions for the overloads that are occurring on certain routes during certain time periods. He discussed customer feedback statistics on weekend service and proposed two options for additional service to the Board to consider. He noted that staff will exercise Option 1 unless they hear otherwise.

Staff responded to various questions.

The Commissioners thanked staff for their work and for being creative in being able to add service to routes that will have a positive impact on ridership.

Motion <u>carried</u>, 6-0.

2. FS 14-079, Adoption of the 2015 Legislative Priorities

Commissioners Keel and Henderson moved and seconded to adopt the 2015 Legislative Priorities as presented in Exhibit A.

Government Relations Officer Justin Leighton presented with Legislative Lobbyist Alex Soldano from Gordon Thomas Honeywell. He noted that the goals were presented to the EFC and that since that meeting the first priority was added to the proposed priorities.

Mr. Soldano responded to various questions regarding the proposed priorities and the State's allocation of resources for transportation money in 2015.

Commissioner Anderson noted that he does not support Bullet Point Nos. 4 and 7 of the proposed priorities listed on Exhibit A.

Commissioner Walker also noted some concerns with Bullet Point Nos. 4 and 7, and noted that number 7 needs to be more in sync with Sound Transit.

Commissioners Anderson and Eidinger **moved** and seconded to omit Bullet Point Nos. 4 and 7 from the proposed priority list described on Exhibit A.

Discussion ensued about what other transit agencies are advocating for.

The amendment carried, 6-0.

The original motion **<u>carried</u>**, as amended, 6-0.

3. FS 14-085, Authority to Execute a Contract with Apollo Video Technology for the Purchase, Install, and Software of Cameras on Buses System

Commissioners Walker and Keel moved and seconded to approve Resolution No. 14-069, authorizing the Chief Executive Officer to enter into and execute a contract with Apollo Video Technology under GSA Schedule pricing, for the purchase, installation, software and training for providing a comprehensive video camera system on Pierce Transit's fixed route fleet in an amount not to exceed \$2,050,391 contingent upon adoption of the 2015 Budget.

Chief Administration Officer Alberto Lara presented on the item. He responded to questions. (*Commissioner Walker left the meeting at 5:41 PM.*)

Commissioner Anderson suggested that in the future, Pierce Transit may want to add legislative priorities relating to the Public Records Act.

Motion carried, 5-0.

INFORMATIONAL BOARD ITEM

Chair Report ~ Vice Chair Vermillion announced upcoming events, which included reappointments to the Puget Sound Regional Council Transportation Policy Board, election of a new Chair and Vice Chair, all-day work session scheduled for February 2, 2015 and Community Transportation Advisory Group recruitments and appointments.

Sound Transit Update – None.

STAFF UPDATES/DISCUSSION

Farebox Installation ~ Fleet Manager Bill Spies noted staff and vendors installed 172 fareboxes on Pierce Transit coaches this weekend. He noted that staff has been providing public outreach on how to use the new fareboxes.

Washington State Auditor's Office Exit Conference ~ Chief Financial Officer Wayne Fanshier announced that an exit conference will be held on December 18, 2015, and no audit findings were issued. Pierce Transit has received a certificate of excellence in budgeting for 30 years in a row and attributed that success to Finance Manager Kathy Sullivant.

EXECUTIVE SESSION

At 5:54 PM, the Regular Meeting was recessed into Executive Session for approximately five minutes to discuss matters relating to litigation, pursuant to RCW 42.30.110 (1)(i). It was announced that formal Board action will occur in open session, following the Executive Session.

The Regular Meeting was reconvened at 6:00 PM.



BACKGROUND:

Pierce Transit's current Microsoft Premier Services Agreement expires on January 19th, 2015. Renewal will provide: up to 794 hours for Support Assistance; up to 90 hours for Problem Resolution Support; Third Tier Support for Microsoft Lync and Exchange; Twelve (12) Onsite Service Resource Site Visits; and Unlimited Access to the Premier Online Website.

Microsoft Premier Support includes the services indicated above, and during the onsite visits they will provide targeted, in-depth training for the Microsoft Lync telephone system, the Microsoft Exchange E-mail system, and SharePoint (our Intranet and document management storehouse). This agreement also provides support for all Agency Microsoft servers – on which all Agency Core Business Systems operate (except for the Agency Trip Planner).

Microsoft is the only provider of these services for the Agency's Microsoft systems. Microsoft offers two methods of providing this support:

- Pay on a per incident basis which would require that we waiting in an incident queue for each incident on a first come basis with all other support calls coming into Microsoft charge is \$275 per hour.
- Enter into a Support Agreement with Microsoft Premier with priority support this is a much more cost effective option as we would far exceed the cost of this agreement utilizing the hourly charge method, and when we do have an issue, it is normally a critical system issue for the Agency that can't wait in a queue for support for any great length of time..

To meet the need to resolve our Microsoft System Support requirements in an effective and expeditious manner we entered into a sole source agreement with Microsoft Premier Services in 2013 – this agreement was approved by the CEO as it was within her signature authority. The Agency's experience with Microsoft Premier Services under the prior contract has been overall positive, and we have found them to be very responsive to our needs and technically superior to other vendors we've worked with.

ALTERNATIVES:

The alternative would be to not renew our agreement with Microsoft Premier. This would require us to pay Microsoft on a per incident basis on a first come basis with no priority support. Having no support agreement in place would leave us with no dedicated support for our critical Microsoft Core Systems or Microsoft Servers.

RECOMMENDATION:

Approve Resolution No. 15-001, authorizing the Chief Executive Officer to enter into and execute a sole source Microsoft Premier Support Agreement renewal with Microsoft Premier Services in the amount of \$384,656 for calendar year 2015.

A RESOLUTION of the Board of Commissioners of Pierce Transit Authorizing the Renewal of a Sole Source Agreement with Microsoft Premier Services for 2015

WHEREAS, to meet the Agency's Microsoft System Support requirements in an effective and expeditious manner, Pierce Transit entered into a sole source agreement with Microsoft Premier Services in 2013; and

WHEREAS, the current Microsoft Premier Services agreement expires on January 19, 2015; and

WHEREAS, by Resolution No. 14-067 approved on the 9th day of December, 2014, the Board of Commissioners of Pierce Transit adopted the 2015 Budget which included a planned expenditure for support assistance and problem resolution for the agency's various telephone, email, document management systems; and

WHEREAS, the proposed renewal of the Microsoft Premier Services agreement ("renewal agreement") provides that the vendor would provide services for support assistance and problem resolution. The renewal agreement provides for up to 794 hours for Support Assistance, up to 90 hours for Problem Resolution Support, Third Tier Support for Microsoft Lync and Exchange, twelve (12) Onsite Service Resource visits, unlimited access to the Premier Online Website, and support for all Agency Microsoft servers – on which most of the agency core business systems operate; and

WHEREAS, the renewal agreement provides that onsite visits will provide targeted, in-depth training for the Microsoft Lync telephone system, the Microsoft Exchange E-mail system, and for Microsoft SharePoint for the new Senior Systems Analyst administering these systems; and

WHEREAS, Microsoft is the only provider of these services for Microsoft's proprietary systems; and

WHEREAS, the Microsoft Premier Services Renewal Agreement in the amount of \$384,656 has been evaluated by staff, is considered to be fair and reasonable; and

WHEREAS, the Board of Commissioners of Pierce Transit finds it in the best interest of Pierce Transit to renew the sole source Microsoft Premier Services Agreement with Microsoft Premier Services.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Pierce Transit as follows:



BALLOT DROP BOX USE PERMIT (Pierce County Auditor)

This Ballot Drop Box Use Permit (hereinafter "Permit") is made and entered into as of the Effective Date (defined in Section 21 below) by and between PIERCE TRANSIT, a Washington municipal corporation (hereinafter "Pierce Transit") and PIERCE COUNTY, a municipal corporation and political subdivision of the state of Washington (hereinafter "Pierce County"). Pierce Transit and Pierce County may hereinafter be referred to collectively as "Parties" or individually as a "Party."

RECITALS

WHEREAS Pierce Transit owns or leases certain parcels of real property consisting of the land and improvements commonly and legally described in **Exhibit A** attached hereto and by this reference incorporated herein (hereinafter "Subject Properties"); and

WHEREAS Pierce County has secured a federal "Help America Vote Act" grant through the Elections Division of the Washington Secretary of State to purchase, install, use and maintain ballot drop boxes of the type and nature schematically depicted in **Exhibit B** attached hereto and by this reference incorporated herein (hereinafter "Drop Boxes") in various locations throughout Pierce County to collect ballots cast by voters in general and special elections conducted by the Auditor of Pierce County pursuant to Chapter 29A of the Revised Code of Washington; and

WHEREAS Pierce Transit desires to make available to Pierce County for the installation, use and maintenance of the Drop Boxes those certain portions of the Subject Properties depicted in **Exhibit C** attached hereto and by this reference incorporated herein (hereinafter collectively "Premises"); and

WHEREAS the Parties agree that it is in their mutual interest and the interest of the general public that Drop Boxes to be located throughout Pierce County; and

NOW, THEREFORE, for in and consideration of the terms, covenants and conditions set forth in this Permit, and other good and valuable consideration, the - receipt and adequacy of which are hereby acknowledged, Pierce Transit and Pierce County hereby agree as follows:

AGREEMENT

1. Incorporation of Recitals. The above recitals are true and correct and are incorporated herein by this reference as if fully set forth.

2. Grant of Permit. Pierce Transit hereby grants to Pierce County, and Pierce County hereby accepts from Pierce Transit, a permit to use the Premises upon the terms, covenants and conditions set forth in this Permit.

3. Permit Period. This Permit shall commence on the Effective Date and terminate at midnight on December 31, 2020 provided Pierce Transit still has possession and use of the Subject Properties (hereinafter "Permit Period"). The foregoing notwithstanding, this Permit shall automatically renew for successive periods of one (1) year each beginning January 1 and ending December 31 (hereinafter "Renewal Period(s)") unless terminated by either Party upon ninety (90) calendar days prior written notice to the other.

4. **Delivery of Possession; Acceptance.** Pierce County shall be entitled to possession of the Premises as of the Effective Date. Pierce County has inspected the Premises and has determined to its complete satisfaction the same are suitable for the uses described in Section 5.1 below.

5. Use of Premises.

5.1 **Permitted Uses.** Pierce County shall use the Premises for the sole purposes of installing, using, maintaining and removing the Drop Boxes and for no other uses or purposes without the prior written consent of Pierce Transit, which consent may be granted, withheld, conditioned or delayed by Pierce Transit in its sole and absolute judgment and discretion.

5.2 Prohibited Uses. Pierce County shall not use the Premises in violation of any statute, rule, ordinance, permit, order, regulation or code in effect and applicable to any part thereof, nor shall it do or permit to be done in or about the Premises, or bring into, keep, or permit to be brought into or kept in or about the Premises, anything that may constitute a waste, nuisance or unreasonable annoyance to Pierce Transit or its customers.

6. Pierce County's Responsibilities.

6.1 Installation. Pierce County shall, at its sole cost and expense, installing the Drop Boxes in good and workmanlike manner in accordance with the manufacturer's specifications and with all laws, rules, regulations, ordinances, permits and requirements of all governmental agencies, including Pierce Transit, having jurisdiction and shall be maintained throughout the Permit Period by Pierce County in a good, neat, clean and sanitary condition and repair.

6.2. Maintenance. Pierce County shall, at its sole cost and expense, maintain the Drop Boxes throughout the Permit Period in good repair and in a neat, clean, sanitary and graffiti-free condition. If any Drop Box is breached, damaged,

vandalized or defaced in any way, Pierce County shall re-secure, repair or replace the Drop Box as soon as practicable after receiving notice thereof.

6.3 Security. Pierce County shall be solely responsible for the security of the Drop Boxes and their contents. If any threat is made with respect to a Drop Box, such as an incendiary or other device, Pierce County shall be solely responsible for dealing with and resolving that threat.

7. Pierce Transit's Responsibilities. Pierce Transit shall: (a) exercise due care and caution with respect to the Drop Boxes while conducting its business operations in and about the Subject Properties and shall, at its sole cost and expense, repair any and all damage to the Drop Boxes caused by the negligent or willful conduct of its elected or appointed officials, contractors, servants, agents or employees; and (b) notify Pierce County immediately if: (i) any Drop Box is breached, damaged, vandalized or defaced in any way; and/or (ii) any threat is made with respect to a Drop Box.

8. Indemnification. Pierce County shall indemnify, defend, and hold Pierce Transit harmless from all claims, liabilities, costs, attorney fees and expenses of any kind, type or nature whatsoever arising out of or in any way relating to: (a) Pierce County's use of the Subject Properties pursuant to this Permit; (b) any activity, work or thing done, permitted or suffered by Pierce County in or about the Subject Properties; (c) any breach or default in the performance of any obligation to be performed by Pierce County under this Permit; or (d) any act or omission of Pierce County or of its elected or appointed officials, contractors, servants, agents or employees caused by negligence or willful misconduct and then only to the extent of its or their proportionate share of liability. Pierce County's obligation to indemnify Pierce Transit under this Section 8 includes an obligation to indemnify for losses resulting from death or injury to Pierce County's elected or appointed officials, contractors, servants, agents or employees, and Pierce County hereby waives any and all immunities it now has or hereafter may have under Title 51 RCW (Industrial Insurance), or other worker's compensation, disability benefit or other similar act that would otherwise be applicable in the case of such a claim and further acknowledges that such waiver was mutually negotiated by the Parties as required by RCW 4.24.115.

9. Default; Remedies. In the event of a default under this Permit either Party may pursue any remedy allowed by law.

10. Waiver. Failure by either Party to promptly enforce any right under this Permit shall not operate as a waiver of such right with respect to any future default.

11. Notices. Any notices required or desired to be given shall be by telephone, electronic mail and U.S. mail to the person(s) set forth below:

14. Counterparts. This Permit may be signed in two or more counterparts, which taken together shall constitute the complete agreement between the Parties, and signatures to this Permit by the Parties transmitted via facsimile shall be acceptable and binding.

15. Prior Agreements. This Permit contains all of the agreements of the Parties with respect to any matter covered or mentioned herein and no prior agreement, letter of intent, negotiation or understanding pertaining to any such matter shall be effective for any purpose. No provision of this Permit may be amended or added to, except by an agreement in writing signed by the Parties or their respective successors in interest.

16. Attorney Fees and Costs. If either Party requires the services of an attorney in connection with enforcing the terms of this Permit, whether or not suit is brought, or in the event suit is brought for the recovery of any sums due under this Permit or for the breach of any term, covenant or condition hereof, the substantially prevailing Party shall be entitled to reasonable attorney fees and all costs incurred in connection therewith, including, without limitation, the fees of experts and professionals, whether at trial, on appeal or without resort to suit.

17. Vacation of Premises. Upon expiration or earlier termination of the Permit Period, Pierce County shall: (a) remove the Drop Boxes and any associated mounting hardware from the Premises; and (b) leave the Premises in a neat, clean, sanitary, and original condition, ordinary wear and tear excepted.

18. Cost of Performance. Except as otherwise expressly provided in this Permit, all covenants and agreements to be performed by Pierce County shall be performed at its sole cost and expense.

19. Severability. Any provision of this Permit that proves to be invalid, void, or illegal shall in no way affect, impair, or invalidate any other provision hereof, and such other provisions shall remain in full force and effect.

20. Governing Law; Venue. This Permit shall be governed by and construed and interpreted in accordance with the laws of the state of Washington. The venue of any action between the Parties relating to the subject matter of this Permit shall be in the Pierce County, Washington.

21. Effective Date of Permit. The term "Effective Date" shall mean the date upon which Pierce County's Executive has signed this Permit Lease as indicated opposite her name below.




EXHIBIT B (Schematic Depiction of Drop Boxes)




EXHIBIT B (Schematic Depiction of Drop Boxes Continued)

BACKGROUND:

In response to the Federal Transportation Act MAP-21, the Puget Sound Regional Council (PSRC) Executive Board has changed the structure of the Transportation Policy Board (TPB) so that transit will be represented in a voting capacity. The new board structure eliminates the prior non-voting transit agency seats with five voting seats: one regional seat for Sound Transit and one specifically designated local transit seat for each county. For the county-wide transit seats, the appointment will be made by the Board of the largest transit agency in the county, but the member will represent all transit interests within the county. The appointment should be coordinated with all designated recipient transit agencies providing transit service within the county.

There are five public agencies that provide transit services in Pierce County: Pierce Transit; Kitsap Transit; Intercity Transit; Sound Transit; and Pierce County government through their ferry service. Because Sound Transit and Kitsap

Transit will have their own seat, Pierce Transit coordinates with Pierce County Government and Intercity Transit when making this appointment.

The Clerk of the Board has coordinated with other public transportation providers in the County to seek nominations, and any nominees received will be listed on Exhibit A to the Fact Sheet. Any individuals listed on Exhibit A will have been confirmed by the Clerk that the individuals are willing to serve should he or she be appointed.

The Board should elect both the representative and alternate by majority vote. The Chair should list the nominees, and call for a vote on each nominee in the order in which they were nominated. The first nominee to receive a majority vote is elected.

The term of those appointed shall be from January 2015 through December 31, 2015.



BACKGROUND

The following proposed amendments to the Pierce Transit Code regarding the Community Transportation Advisory Group (CTAG) add language to enhance the CTAG recruitment process, leverage recruitments that yield a larger pool of well-qualified candidates and furthers the Board's intent to achieve broad and diverse representation on CTAG.

Proposed CTAG Amendments

Pierce Transit Code Section 1.94.050 requires that members be selected through an application process. The goal of that process is to identify eligible participants that represent a broad cross-section of populations. The Pierce Transit Code provisions regarding CTAG currently require that applicants either reside or work within the

Pierce Transit service area. The current language does not take into account that there may be well-qualified and interested individuals who are otherwise actively engaged in the service area through their school, civic involvement, or volunteerism. Nor does it take into account that prospective CTAG members particularly youth/students and retirees may not be employed but may have knowledge of and interest in the Pierce Transit system as a result of their various activities with the service area.

Consequently, the following amendments to Pierce Transit Code Section 1.94.050 – Membership Selection Process are proposed to expand the opportunity to serve on CTAG to youth, students, and other interested individuals who have demonstrated active engagement in the service area through their volunteer work or other civic involvement. The following amendments are intended to further the Board's intent of broad and diverse representation on CTAG:

- Members must be at least sixteen (16) years old at the time of application; and
- Applicants for CTAG must meet the application's stated minimum qualifications for service and must establish that they either live, work, or attend school in the Pierce Transit service area. An applicant may be qualified if he or she can otherwise demonstrate active engagement in the Pierce Transit service area through volunteer activities or other civic involvement within the Pierce Transit service area.

Furthermore, the current CTAG composition found at Pierce Transit Code Section 1.94.040 does not provide the flexibility of appointing an alternate to the CTAG when a vacancy occurs. When read with the current PT Code Section 1.94.050 whenever a vacancy occurs, a full recruitment and application process is required.

From time to time, during the usual CTAG application and interview process, there may be more qualified and interested applicants than there are open positions on CTAG. In such circumstances, having an otherwise-qualified and vetted applicant as a CTAG alternate would allow the alternate to immediately fill a vacancy without requiring another mid-term recruitment. This would save the Agency and the Board time and effort and would allow the CTAG to make smooth transitions as vacancies occur. Consequently, Staff proposes the following additional amendments:

"The CTAG shall be composed of no more than nine members appointed by the board.

At the discretion of the board, after the usual application and interview process is complete, if there are more qualified and vetted applicants than there are available CTAG positions, one alternate may be appointed by the Board to serve a one year term. In the event of a vacancy on the CTAG, the alternate will immediately fill the vacant CTAG position and may serve on the CTAG with all rights and responsibilities of a CTAG member through the remainder of the unexpired term associated with the vacancy. The alternate must meet all of the qualifications of a regular CTAG member but the alternate holds no voting rights or rights to hold office. The presence of the alternate does not count towards a quorum of the CTAG.

Members shall reflect Pierce Transit's service area and strive for broad, inclusive, regional, and diverse representation to increase the reach and effectiveness of CTAG's purpose. Pierce Transit staff cannot serve as members of CTAG, but may support CTAG with the selection of members, the conduct of meetings, the creation of agenda items, and communication with Pierce Transit or the public."

ALTERNATIVES

 Decline to make all or some of the proposed amendments to the Pierce Transit Code to provide for an alternate and to expand membership opportunity to youth, students, or others with volunteer or other civic involvement in the service area. This would maintain the current Code language which requires the Agency to conduct full recruitments each time a vacancy occurs on the CTAG, and which does not allow for the participation of youth, students, or others with demonstrated involvement in volunteer or civic activities within the service area.

1.94.040 - Composition.

The CTAG shall be composed of no more than nine members appointed by the board.

At the discretion of the board, after the usual application and interview process is complete, if there are more qualified and vetted applicants than there are available CTAG positions, one alternate may be appointed by the Board to serve a one year term. In the event of a vacancy on the CTAG, the alternate will immediately fill the vacant CTAG position and may serve on the CTAG with all rights and responsibilities of a CTAG member through the remainder of the unexpired term associated with the vacancy. The alternate must meet all of the qualifications of a regular CTAG member but the alternate holds no voting rights or rights to hold office. The presence of the alternate does not count towards a quorum of the CTAG.

Members shall reflect Pierce Transit's service area and strive for broad, inclusive, regional, and diverse representation to increase the reach and effectiveness of CTAG's purpose. Pierce Transit staff cannot serve as members of CTAG, but may support CTAG with the selection of members, the conduct of meetings, the creation of agenda items, and communication with Pierce Transit or the public.

1.94.050 - Membership selection process.

Broad representation by CTAG is critical. The board of commissioners expects CTAG members to serve as representatives of their respective communities and constituents, using all available venues to gather information and prepare for productive participation. To achieve this outcome, CTAG recruitment will be through the Pierce Transit website, local newspapers, and communication with established community partners. Members will be selected through an application process <u>that will set forth the minimum qualifications for service</u>. The goal is to identify eligible participants that represent the populations listed below. The board, or a designated subgroup of the board, will review applications along with staff and recommend prospective new members for appointment by the board. Staff will recommend members for reappointment to the board.

CTAG members must be at least sixteen (16) years old at the time of application; and

<u>Applicants for CTAG members must meet the application's stated membership</u> requirementsminimum qualifications for service and must establish that they either live, reside or work, or attend school in the Pierce Transit service area. An applicant may be qualified if he or she can otherwise -or demonstrate active engagement in the Pierce Transit service area through residency, school, work, volunteer activities ism, or other civic involvement-or work within the Pierce Transit service area. Service users (fixed route, paratransit, vanpool);

Chambers of commerce;

Community-at-large;

Students;

Faith community;

Civic associations;

Senior citizens;

Business owners;

Social service agencies.

This list is neither comprehensive nor exclusive. The board and staff will have discretion to expand this list or recruit individuals so long as CTAG's composition meets the goal of broad, inclusive, regional, and diverse representation. Membership applications will be made available to all who have requested an application, to people suggested by CTAG members, the board, staff, members of the community, or organizations and agencies representing the participation list above.

BACKGROUND

Pierce Transit's Community Transportation Advisory Group (CTAG) is comprised of up to nine (9) community members. As of August 2014, there were four vacancies on the CTAG, and another vacancy was expected as of December 31, 2014. Two vacancies occurred as a result of expired terms and two as a result of resignation due to work and schedule conflicts.

The Board appointed a subcommittee comprised of Commissioner Vermillion and Commissioner Henderson to work with staff to conduct a recruitment, application, and evaluation process to fill the current and expected vacancies and to make recommendations to the Board for appointment to the CTAG.

Recruitment Process

As provided by Pierce Transit Code Sections 1.94.040 - .060, the Agency recruits and selects new CTAG members through an application process. For this recruitment, advertisements ran in local weekly and daily newspapers from October 27 through November 14, 2014. Publications included the TNT, Herald, Gateway, Volcano, Ranger, NW Airlifter, TNT GO, Tacoma Weekly, Fife Free Press, and the Milton-Edgewood Signal. The Agency also posted the announcement and application materials on its website, Facebook page and internal intranet. Employees, the Board and current CTAG members disseminated the announcement to their various networks, and the Business Development Office notified each of its three Community Investment Teams of the vacancies. A press release also went to media partners, and application materials were mailed to anyone who made a request.

The Agency received a number of applications in response to its recruitment and outreach. The application materials for all applicants were reviewed by the Subcommittee, the Pierce Transit CEO and the Pierce Transit CTAG Liaison. The Board's Subcommittee selected five applicants for in-person interviews.

Proposed Appointment of new members and an alternate

Following the completion of interviews on December 10, the Subcommittee recommended that the Board appoint Sandy Paul, Hongda Sao, Chris Beale and Steve Schenk to fill four current CTAG vacancies. Their terms would begin January 1, 2015 and run through December 31, 2017.

The Subcommittee also recommends that Richard Zalucha be appointed as the alternate if the PT Code Section 1.94.040 is amended to provide for an alternate.

The applications of Ms. Paul, Mr. Sao, Mr. Beale, Mr. Schenk and Mr. Zalucha are attached as Exhibits A-E.

Proposed Reappointment of Paul Bala

Pierce Transit Code Section 1.94.050 provides that staff will recommend members for reappointment to the Board. Staff recommends that Paul Bala, a current CTAG member, be reappointed to a one-year term beginning January 1, 2015 and ending December 31, 2015.

Mr. Bala has a strong interest in SHUTTLE and special transportation for seniors and persons with disabilities. As one of the original CTAG members, Mr. Bala consistently offers meaningful input to the plans, projects and proposals brought before him at CTAG. Although his initial term expired December 31, 2014, he has requested to stay for one additional year to support the success of CTAG's new members.

ALTERNATIVES:

1. Decline to appoint some or all of the proposed candidates for appointment or reappointment to the CTAG and direct staff to continue the recruitment process to allow for additional applications.

RECOMMENDATION

- 1. Appoint Sandy Paul, Hongda Sao, Chris Beale, and Steve Schenk each to a CTAG term beginning January 1, 2015 and ending December 31, 2017; and
- 2. Appoint Richard Zalucha as an alternate (subject to the approval of Resolution No. 15-005); and
- 3. Reappoint Paul Bala to a one-year term beginning January 1, 2015 and ending December 31, 2015.

Screening Questions Sandy Paul

Describe the top three transportation issues of concern and importance to you and your perspective on the role of a CTAG in addressing those issues.

Our transportation system is inadequate. We live in a culture of driving alone in our cars, which is so 1950's. It was born with the interstate system, which is obsolete. Also obsolete is our community perspective on public transportation. I dream of the day when I can walk out my door, get on a bus, and go anyplace in the world. I can almost do that now, but it would take me half the day just to get to the airport!

It's cool to ride the bus and the train, and those that are running are completely full during the commute hours. The problem with that is that buses cannot get anywhere, either, on our gridlocked roads. And I think it's OK to have partially full/empty busses during the day when usage is, obviously, less.

Passage of I-695 significantly reduced the taxes paid, created economies of the scale that no one imagined possible, and showed, unfortunately, that government CAN do more with less. That day is over. No one wants to see their pay check get smaller. Or even stay the same. That same economy funds the services expected by all of us. It's time to find new revenues and support that. I'm still waiting for that \$500 I used to pay for license tabs to be sucked out of my budget by some other means. It's not happening. A meager \$30 *Discover* parks pass and *Good-To-Go* pass do not go far enough to fund much.

Therefore I would propose improving all public transportation significantly and tell the community that it's 'not your father's Oldsmobile'; complete SR 167 to the Port of Tacoma and move forward on SR 509; approve a tax package that would see these projects, and others that also need to be considered, to completion. CTAG should be at the table discussing how to get these changes implemented.

Explain how your membership on Pierce Transit's CTAG would improve communication and add value for your employer, the community or student group with whom you are affiliated.

I have participated in the Tacoma Junior League since 1998, funding projects and serving the community. I have worked in government and am personally acquainted with many of the players. I have served on a Transit Advisory Committee before and I clearly understand the role of this committee, and that if this committee is not a bit more assertive, it surely should dispatch a representative to assertively support an improved transportation system to include transit, ferries, trains, and highways. Transit should be at the forum to support a strong transportation system in the Puget Sound region, not just for the benefit of Pierce, King, Kitsap and Thurston counties, but for the state of Washington and the nation as a whole. (I am not assuming that is not already happening.)

Answer to Question 1.

 - 1. Sustainable transportation funding With bus transportation services so dependent upon sales tax revenue, which can fluctuate with the ebbs and flows of the consumer economy, I am concerned about sources of stable, sustainable funding to support bus services that so many are dependent upon. While this is mostly an issue at the state legislative level, I believe that the CTAG can play an important role in advocating for other sources of revenue that can diversify Pierce Transit's revenue 'portfolio' and stabilize bus service levels without having to ask the public at-large to approve regressive sales tax increases whenever the economy weakens.
 - 2. Transit-oriented development As a city planner and a current member of the City of Tacoma's Planning Commission, I professionally understand and advocate for housing options that complement and integrate well with mass transit options. In order for average people to make the switch to using mass transit, as I do 4-5 times a week, bus services must be close to housing and urban areas, and easily accessible to those whose busy lives may make it challenging to consider switching to transit commuting.
 - 3. Comfortable, safe and accessible bus stops and transit centers In order to complement transit oriented development, I believe that bus stops and transit centers must be safe, comfortable and accessible to all users. Improvements such as more covered shelters at bus stops are needed to make mass transit usage more attractive to those who can drive alone, but are interested in making the switch to bus commuting.

- 1. Top three public transportation issues of concern.
 - a. Providing tailored community services as per the strategic direction of Board of Commissioners. This is important for public perception and costs. An empty bus adds to the perception many have of waste of public transportation. But, these "tailored community services" cannot mean the elimination of routes lower income people depend on. It may mean looking at ridership levels and adjusting the size of the transport vehicle and scheduled times.
 - b. Improve the use of mix mode commuting. Educate the public on what it is and how it can be a part of their commute.
 - c. Improve Integrated Regional Transportation system and planning. Lobby for the continued integration of regional transportation planning not just with the transportation commissioners but public, state representatives and WSDOT. Public transportation planning and highway planning must be integrated. I believe the citizen, tax payer perspective and user perspective is an important portion of the CTAG.
- 2. CTAG and improving communication.
 - a. I am a member of the Steilacoom Kiwanis; PTA; Military Officers Association of Puget Sound Board of Directors; precinct committee officer and active volunteer working with the Steilacoom School District and City of DuPont on their comprehensive plans. The education of local leaders (many who never or have never rode public transit) is critical. This came to light for me when listening to WSDOT representatives explain how they were lessening the burden on the JBLM corridor on I5. No mention of public transportation and no mention of commute reduction. The groups I interact with include state senators and representatives. Many give little thought to public transit or integrated planning. I hope to do my part to change their minds. I also hope to educate the leaders in DuPont to rejoin Pierce Transit District and include public transit in their planning.
- 3. Background.

I spent 30 years in the military retiring at the executive level in June 2014. I have used public transport internationally (where intermodal public transit truly works), in Pierce County; Minneapolis and was a daily workday user 2011-2013 in Chicago. I have experience in logistics; multimillion dollar budgeting; and scheduling (see attached resume). Building more roads is not the way to combat traffic. Integrated planning between highways and public transit is. While living in Germany, we could bus, train or street car anywhere conveniently and reliably. In the United States, very few cities or areas can do that which adds to the perception money spent on public transport is wasted. We can do better, be integrated and I hope to provide a citizens voice to this.
