#### **An Update for our Vanpool Customers**

Thank you for riding Pierce Transit vanpool. Our road has been up, down, and not without curves as the Agency makes difficult decisions to sustain service in this uncertain time. As you know, Pierce Transit proposed a fare increase for transportation services, including vanpool. On August 30, the Board of Commissioners Finance Committee held a Public Hearing accepting oral and written testimony relevant to the fare revisions. On September 13, the Board of Commissioners will vote on the fare proposal measure. If approved, new fares will take effect November 1, for November vanpool fares, and we will mail revised vanpool fare charts and report forms to volunteer bookkeepers. If the Board does not approve the fare proposal, we will share that decision with you.

In addition to the potential fare increases and recent layoffs, Pierce Transit continues to restructure and consolidate programs and cut expenses wherever possible. # **Driving Tips**



# **Negotiating a Corner**

Tools to Use.

First and foremost, **slow before the corner** — whether it's at a city intersection (all of us), on a freeway entrance ramp (most of us), or on a mountain highway (our two groups commuting to Ashford). Slow down by braking or easing off the gas pedal on the straight road BEFORE the corner. The vehicle is more stable in a straight line than if you try to brake in the middle of the corner. The objective is to accelerate slightly through all corners giving the vehicle better balance, and you gain more control. You can usually accelerate safely in a corner but you can't always slow down safely, especially in a van.

The second thing to consider is that the less you turn the steering wheel, the more control you have. Negotiate the corner properly by turning the wheel as little and slowly as possible, and unwind, or straighten the vehicle in the same manner, giving you a smooth flowing arc through the corner. Your riders will appreciate smooth cornering, and you will be in a much safer position - unlike the driver in the next article. Read on for an account of a vanpool group's crazy ride one morning.



# **A Crazy Ride**

#### A June Commute - Shared by Bob Bowen

"The morning started out with a crazy ride in van 7057! We were getting onto the 72<sup>nd</sup> Street freeway entrance, turning to the right to get on. There was traffic turning left to get on to the entrance as well. When we entered the on ramp, a mini-van turning left sped up quite fast. It was wet and her van did a 180 degree turn, moving in a forward direction right toward us. John, our driver, saw everything and made evasive maneuvers to get us out of her way. And because he had entered the ramp at a reasonable speed, he slowed the traffic behind us helping to avoid not only the minivan, but others from a possible collision. The woman pulled over on the shoulder, sped up and got in front of us. It appeared that she did not learn from her experience. Thanks to John T., we are not a statistic and we made it to work safely." Way to avoid that collision. John!

# **Avoiding a Collision**

BRAKE PROPERLY! Most people slam on their brakes and skid right into the other car. Since our vans have anti-lock brakes system (ABS), press firmly and steadily — do not let up on the brake pedal. The ABS works only with the brake pedal pushed down.

STEER TO AVOID! As defensive drivers, you should be aware of surroundings so you may see an escape route. Keep your eyes open; always look and steer where you want to go. A good grip with both hands on the wheel helps keep the vehicle under control.

SPEED UP. Sometimes, it's best or necessary to speed up a bit to avoid a collision — if you are about to be hit from the side or from behind and there is room to the front of you to get out of the way. Slow down after passing the danger.

## **Back to School**

#### School Zone Reminders and DOL Rules of the Road

Slow down! Speed limits, unless otherwise posted, are 20 mph in school zones. Obey directions from school crossing guards and school zone signs. Automated traffic safety cameras monitor many areas for safety — citations are costly.

Stop! You must stop for a school bus that is stopped with its red lights flashing whether it is on your side of the road, the opposite side of the road or at an intersection you are approaching. You are not required to stop for a school bus with red lights flashing when the stopped school bus is traveling in the opposite direction and the roadway:

- has three or more marked traffic lanes,
- is separated by a median, or
- is separated by a physical barrier.

After the school bus red lights have stopped flashing, watch for children along the side of the road and do not proceed until they have completely left the roadway.

The completed Appendix satisfies American Driving Records/Core Logic who acts on behalf of Pierce Transit to obtain the abstract of driver records for each applicant. # **Transponders and Shields**

#### **Care and Use**

When you swap vans, check the shield before driving off our lot. Have the person sitting shotgun double check the shield BEFORE the daily commute. Additionally, we are placing reminders on the shields in our fleet: "Attention: Do not remove shield unless crossing the Narrows Bridge." Help us avoid needless toll charges.

# **MVR Surprises – Gotcha!**

#### Something you would rather just forget, perhaps?

Not! We need to know when you receive a citation or are involved in an accident — even in your personal vehicle! The incident may not disqualify you from driving the vanpool, but we need to manage our risk. Thank you.
