#### **RESOLUTION NO. 2023-004**

A RESOLUTION of the Board of Commissioners of Pierce Transit Acknowledging Pierce Transit's Commitment to Support Youth Wellbeing and Help Combat Youth Violence by Providing Access to Youth Programs in the Pierce Transit Service Area

WHEREAS, youth violence is a significant problem that affects thousands of young people each day, and in turn, their families, schools, and communities; and

WHEREAS, youth violence is a multi-faceted, complex issue involving multiple factors whereby prevention cannot be accomplished by just one sector alone, but by a collaborative effort of community leaders and partners; and

WHEREAS, young people are our future, and programs and initiatives for youth and at-risk youth that foster a safe, healthy, engaged, and supported environment are an important cornerstone to improving youth wellbeing and combating youth violence; and

WHEREAS, Pierce Transit recently implemented a new program whereby youth 18 years and younger may ride Pierce Transit services for free, increasing access and opportunity to attend youth-oriented programs and events and thereby helping kids remain off the streets, out of trouble, and helping to set them up for success.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Pierce Transit as follows:

<u>Section 1</u>. Direct staff to work with community and school leaders to ensure that bus schedules align with programs that support youth and at-risk youth and, where possible, adjust bus schedules to provide better access and opportunity to these programs.

<u>Section 2.</u> Direct staff to work closely with community and school leaders to promote the Free Youth Transit Pass so that youth are aware of the opportunity to ride transit for free.

Chair Campbell welcomed board members, staff, and citizens to the meeting and provided attendees with instructions for meeting participation.

#### **PRESENTATIONS**

#### 1. Honoring Joseph Rochon for Operator of the Month for April 2023

Transportation Assistant Manager Scott Gaines honored (*Commissioner Roscoe joined the meeting at 4:04 p.m.*) Operator Joseph Rochon for being selected Operator of the Month for April 2023. He detailed his accomplishments, noting that he has made the Million Miler club two times, provides excellent customer, has outstanding safety record, helps with the Operator Shake Ups, and manages the vacation scheduling process for the operators.

On behalf of the Board, Chair Campbell thanked Mr. Rochon and all operators for the work they do for the community.

#### **PUBLIC COMMENT**

Chair Campbell provided participation instructions to the public and opened public comment.

No written or public comments were received, and public comment was closed.

Service Planning Assistant Manager Lindsey Sehmel presented on the item and noted that service recovery would take a little longer than hoped for due to the labor shortage of operators and mechanics. She reviewed the RFP process and advised that the contract includes a 20 percent contingency.

Ms. Sehmel advised that the leading principles of the work will be focused on Equity, Route Performance, and Regional Access. She reviewed the tasks that would be completed and projected timeline.

Commissioners Walker and Hines <u>moved</u> and seconded to authorize the Chief Executive Officer to enter into and execute a professional services agreement with Nelson Nygard (contract No.1618) to assist the planning department with the 2023 Recovery and Restoration Fixed Route Services Plan in an amount not to exceed \$251,965.20.

The motion <u>carried</u>, 7-0. (Commissioner Roscoe was not present for the vote.)

2. FS 2023-020, Authorize the Chief Executive Officer to Increase the Current Recruitment Referral Incentive Amount and add a New Hire Incentive Bonus for Bus Operators and Journey Level Mechanics Pursuant to the Guidelines Presented in Exhibit A

Human Resources Manager Tara Schaak presented on the item. She reviewed the current employee referral program, which was launched January 2020, noting that the existing referral program has helped recruit new employees, but recruitment levels remain relatively low in the operator and maintenance ranks.

Ms. Schaak reviewed the new referral program, noting that this proposal would supplement the current program and would include the following:

\$5000 Recruitment Referral for our employees to refer Operators or Journey Mechanics and a \$5000 New Hire Signing Bonus for Operators and Journey Mechanics. Both referrals to be paid out ½ after probation is passed and ½ after one year completed. No employee is eligible for both the Recruitment Referral and the New Hire Signing Bonus.

Ms. Schaak advised that the referral incentives will be funded by unfilled positions.

Commissioners Walker and Reynolds <u>moved</u> and seconded to authorize the Chief Executive Officer to increase the current Recruitment Referral Incentive amount and add a New Hire Incentive bonus for Bus Operators and Journey Level Mechanics pursuant to the guidelines presented in Exhibit A.

#### **REVIEW AND DISCUSSION**

#### 1. Zero Emissions Bus (ZEB) Transition Study

Senior Planner Mark Eldridge kicked off the presentation for the ZEB Transition Study, advising that the plan contains a short-term goal for the agency to transition 20 percent of its Pierce Transit bus fleet to Zero Emissions by 2030, includes a long-term strategy to transition the entire Pierce Transit bus fleet to Zero Emissions between 2029-2042, and includes a financial analysis of the transition. He advised that the agency cannot move forward with the Transition Plan unless Pierce Transit receives funding from outside sources.

Mr. Eldridge gave a high-level overview of the talents and experience of the HDR staff who developed the ZEB Transition Plan and route modeling.

Mr. Eldridge reviewed the key points of the proposed Transition Plan, which included both short and long-term planning and noted that in 2027 the agency will look at Hydrogen Technology, as the technology is advancing fast.

Mr. Eldridge advised that the Transition Plan also includes a Workforce Development element and provides for additional training and apprenticeship opportunities. He advised that Workforce Development training was included in the NOLO grant the agency recently applied for.

Zero Emissions Fleet Coordinator Nathan Groh reviewed the 2023-2028 near-term bus deployment strategy, which included both on-route and on base charging stations within the Pierce Transit system, emphasizing that the proposed Transition Plan pertains to the Pierce Transit bus fleet and not Sound Transit's fleet.

Mr. Groh reported that the long-term strategy period is defined from 2029-2042 and advised that the agency will need to decide before this period if it should pursue Hydrogen Fuel Cell Technology.

Mr. Groh discussed the strategy for transitioning to Hydrogen Fuel Cell infrastructure, detailing the agency's infrastructure needs to accommodate this technology. He advised that the financial estimate for this technology only covers capital costs from now to 2042, noting that costs to transition to Battery Electric Bus are estimated at \$574 million and costs to transition to Hydrogen Fuel Cell are estimated at \$660 million.

Planning Manager Tina Lee spoke on the financial analysis of transitioning to a full Zero Emissions fleet, noting that it is a long-term strategy that will take years to fully implement, along with a lot funding.

Ms. Lee closed her presentation by inviting the Board to submit any comments they may have on the proposed Transition Plan, advised that Pierce Transit applied for a

large capital grant of 20 electric buses, and acknowledging that the agency will continue to coordinate and grow partnerships with utilities for infrastructure support.

#### **STAFF UPDATES**

#### 1. CEO'S Report

CEO Griffus reported on the following items:

- Value Engineering work is currently underway for the BRT project in effort
  to speed up project delivery to our customers, minimize property impacts to
  property owners and business along the corridor, and to deliver the project
  within budget. He advised that a study session meeting will be scheduled in
  June to examine changes that could be made to the project.
- Fare free service was provided on Earth Day, April 22, and fixed route ridership was approximately 13 percent higher than the previous Saturday.
- June is Ride Transit Month; no fares will be charged on Thursday, June 1 to encourage the use of public transportation
- A ribbon cutting ceremony will be held Thursday, June 1 to celebrate the new Fuel and Wash facility at Pierce Transit operations base.
- The 2023 Pierce Transit Roadeo will be held Sunday, June 4 starting at 8:00 a.m.
- Announced that the Agency's 2022 Report is available and provided a highlevel overview of the content that is included in the report. A link to access the report was provided.
- Recognized Deanne Jacobson, Clerk of the Board, for 10 years of service at Pierce Transit.

Chair Campbell reported on the following:

- At the June 12 regular meeting, the Board will conduct elections for the Chair and Vice Chair positions, with the new leadership beginning in July.

Vice Chair Walker reported that the Hilltop Extension is expected to open in August or September.

Work is underway to determine if there could be additional Sounder Train runs to the South Sound. The public will have an opportunity to provide comment on this matter.

#### 3. Puget Sound Regional Council Transportation Policy Board Update

Reported that no meeting will be held in May. Reported on the work that was done at the April meeting.

This item is being placed on the consent agenda as the advertising sales contract is a revenue sharing contract between Pierce Transit and the vendor and does not result in any expenditures from Pierce Transit.

Pierce Transit has a history of contracting with a qualified firm to sell and place advertisements on Pierce Transit's buses, paratransit vehicles, and advertising shelters to generate revenue. The current contract with Lamar Transit LLC expires June 30, 2023.

A Request for Proposals (RFP) was released on April 21, 2023, and was advertised on Pierce Transit's website, Builder's Exchange of Washington, The Daily Journal of Commerce, Tacoma Daily Index, and Office of Minority & Women's Business Enterprises (OMWBE). One (1) company, Lamar Transit, LLC, submitted a Proposal that was due on May 11, 2023.

An Evaluation Committee reviewed the proposal and scored the proposal based on the following criteria:

- 1) Minimum Annual Guarantees and Pierce Transit Revenue Percentage
- 2) Comparative Work Experience. Quality and Experience of Staff.
- 3) Ability to meet the Requirements in the Scope of Work as demonstrated in the content and presentation of written Proposal.
- 4) Proposer's experience with direct application products, other innovative products, and their ability to integrate with current products.

Lamar Transit, LLC, has many years of experience in the transit advertising industry, including contracts with multiple government agencies in the Pacific Northwest such as: Pierce Transit, Community Transit, City of Everett, Whatcom Transportation in Bellingham, Cherriots in Salem, Oregon, Corvallis Transit System in Corvallis, Oregon, and Rogue Valley Transportation District in Medford, Oregon. Pierce Transit staff have worked with Lamar Transit, LLC, for about six years, and staff from multiple departments have provided strong positive feedback regarding their past and present work with the company. The Evaluation Committee scored the submitted proposal and unanimously agreed to move forward with awarding the contract to Lamar Transit, LLC.

Lamar's proposal to Pierce Transit included the following revenues over the life of the eight-year contract plus the optional ninth contract year, which would begin on July 1, 2023:

The Evaluation Committee concluded that Lamar's proposal is thorough, conveys a clear understanding of Pierce Transit's advertising needs coupled with actual experience working with Pierce Transit, has positive references, and proposes a strong revenue package over the upcoming nine years.

#### STAFF RECOMMENDATION:

#### BACKGROUND:

The purpose of the CTAG is to offer an opportunity for community stakeholders to provide feedback and suggest improvements and recommendations on plans, policies, and services offered by Pierce Transit. CTAG is an integral part of the Agency's overall public involvement efforts and an important conduit for obtaining public input, communicating to the public and encouraging public support for transit. Pierce Transit's Community Transportation Advisory Group (CTAG) is comprised of no less than nine (9) and no more than twelve (12) community members.

There are currently eleven members and one vacancy on the CTAG. It is the preference of CTAG to recruit more than the minimum number of members (alternates) to ensure the minimum is maintained if unexpected departures occur throughout the year.

As provided by the CTAG Charter, the Agency recruits and selects new CTAG members through a competitive application process to fill CTAG vacancies with members that represent the broad diversity of the Pierce Transit service area. Advertisements were published in local weekly papers, shared through the Tacoma-Pierce County, Puyallup, Fife, and Lakewood Chambers of Commerce, and were posted on Pierce Transit's website, Facebook, and Twitter accounts, and announced in the agency's community newsletter.

The application period was open for the full month of April. Pierce Transit received two applications. The CTAG Liaison selected applicants for interviews based upon how prior work experience, education or volunteer activities contributed to the improvement of public transit, how they felt public transit benefits people who do not regularly ride the bus, leadership experience and what community networks or groups would be served by their presence on CTAG. Then, a selection committee comprised of a CTAG member and members of Pierce Transit staff participated in the interviews, ranking candidates according to type and size of constituent group represented, leadership experience, community connections, and communication opportunities, and ability to bring unique perspective to CTAG.

Following the completion of interviews, Kye Robinson is recommended by the selection committee to fill the current CTAG vacancy. Parker Hill is recommended by the selection committee to fill as an alternate appointment for any vacancy that occurs within the next 12 months. Their terms will begin June 22, 2023.

#### **BACKGROUND:**

Staff requests authority to renew the lease agreement with Jenco Development Company, LLC, for the property located at 104th Street Court South, Lakewood, for continued use by the Agency's SHUTTLE paratransit service provider.

Pierce Transit provides specialized transportation services for disabled and elderly passengers that are unable to use fixed-route service. A portion of the service is provided by a contractor using Pierce Transit vehicles (currently 76 SHUTTLE vehicles). Pierce Transit has been leasing office, maintenance, fueling and parking space for the contract service provider at this location since 1999.

The current lease expires on June 30, 2023. In preparation for lease expiration, staff and the contract service provider have reviewed and considered other properties. No other properties met our operational criteria which were: a) proximity to Pierce Transit; b) easy and close access to the freeway; c) office and maintenance space; d) secure parking; e) convenient access to a fueling facility; and f) need for minimal tenant improvements. The current space meets most of our criteria, and the owner has agreed to our requested tenant improvements to install two (2) new light poles with lights along the premises fronting 104<sup>th</sup> Street South.

The proposed monthly rent is \$17,400 for the first lease year with an approximate three percent increase for each of the following years. Included in the Lease Agreement is the estimated triple net charges. It is Pierce Transit's responsibility to make monthly estimated triple net payments. These monthly triple net payments will be reconciled with actual costs at the end of each calendar year.

The lease is for a three (3) year term and provides Pierce Transit with the option to renew for up to two (2) one (1) year extensions at the negotiated rates and terms. Staff will return to the Board for approval of any renewals of this lease.

Staff had the agency's real estate broker evaluate rental rates in the I-5 corridor and determined that the rate is considered current market rate for the types of spaces being leased.

#### **ALTERNATIVES:**

The alternative would be not to renew the agreement with Jenco; however, Pierce Transit would still need property to continue to operate contracted SHUTTLE services from and an alternate property is not available at this time.

#### **RECOMMENDATION:**

Staff recommends renewal of this lease with Jenco Development, LLC for five years at the initial monthly rate of \$17,400 with an annual increase of approximately three percent.
