

# Tacoma Dome Parking Garage – Secure Bike Parking Area Agreement

Pierce Transit manages the Secure Bike Parking Area in the Tacoma Dome garage (424 E 25<sup>th</sup> St, Tacoma). In order to provide the safest possible bicycle parking, a key will be required to access the Secure Bike Parking Area. A key will be issued, on a space-available basis, to any cyclist who fills out this application form and pays the associated fees.

User fees are \$8.00 per quarter (three months) or \$25.00 per year. You will be charged a one-time non-refundable fee of \$5.00 for a key, and the charge to replace a lost key is \$5.00. Please see schedule below for user fee information. Cyclist applicant approval entitles the user to park one bicycle per day. Fees are subject to change and use is subject to availability.

To apply:

1. Print out and complete this agreement. Any field noted with \* is a required field.
2. Bring the agreement and payment the Bus Shop to receive your key:

Walk up hours are from 7:00 am to 6:00 pm on weekdays. (Check for reduced hours on and around holidays.)

This document constitutes the entire agreement relevant to use of the Secure Bike Parking Area, and execution of it constitutes acknowledgement by the applicant that the applicant has read and agrees to the terms and conditions.

## Secure Bike Parking Area Terms:

1. User agrees to use the bicycle cage only for the purpose of short term bicycle storage and/or the storage of bicycle accessories.
2. User acknowledges that he/she is using the Secure Bike Parking Area facility at his/her own risk.
3. User agrees to not use the Secure Bike Parking Area for any activity that is prohibited by law.
4. User acknowledges that unless prior arrangements have been made with Pierce Transit, bicycles and/or bicycle accessories left unclaimed after 30 days shall be disposed of.
5. User acknowledges that there is no attendant on duty.

## Responsibilities of User

It is your responsibility as a user to keep the bike area clean, ensure that the door is locked and report any damages to the Secure Bike Parking Area or problem with the lock immediately to the Pierce Transit Customer Service at (253) 581-8000. Users must supply their own locks or bicycle security tools. It is your responsibility to keep your personal information up to date when changes occur. It is your responsibility to use the Tacoma Dome Station and Secure Bike Area in compliance with local, state, and federal laws and in accordance with Pierce Transit policies.

### Limits of Liability

Pierce Transit or Diamond Parking, their directors, representatives, agents and employees shall not be liable for injury of any kind to user or loss, theft, or damage to bicycle and other property arising out of the use of the Secure Bike Parking Area.

### Termination/Cancellation

Either party may terminate this agreement upon ten (10) days' notice. Non-compliance with any conditions contained herein shall constitute a default in the terms of this Use Agreement. Upon termination the user is responsible for removing any property from the Secure Bike Parking Area. If Pierce Transit terminates this Agreement for default or non-compliance, the user will not be entitled to reimbursement of user fees. User fees may be reimbursed on a pro-rata basis if Pierce Transit terminates for convenience. If you fail to remove your property upon termination, it will be disposed of as abandoned property. Pierce Transit reserves the right to refuse use to any applicant or terminate this Use Agreement at any time.
